3. Item description: fire extinguishers OU-5

### Technical characteristics

The carbon dioxide fire extinguisher OU-5 is fire extinguishing equipment designed to extinguish fires using CO<sub>2</sub> (carbon dioxide). It is most effective against fires involving electrical equipment or materials that require the use of non-flammable breathing material.

Main characteristics of OU-5:

Volume. The volume of the OU-5 fire extinguisher is 5 kg (amount of CO<sub>2</sub> gas).

Fire safety class. It is used for class B and C fires involving liquids and gases.

Mixture. It uses pure CO<sub>2</sub> gas, which does not leave residues.

Operating conditions. It quickly and safely extinguishes fires, especially electrical equipment, since the gas does not conduct electricity and does not damage equipment.

Operating distance. Allows you to extinguish a fire from a distance of 1-2 m.

Operating temperature. It works from -20°C to +50°C.

Advantages of use:

No balance. Leaves no chemical residue, ideal for extinguishing fires in rooms where a clean environment is required.

Safety. CO<sub>2</sub> does not damage electrical equipment and does not conduct electricity.

Easy to use. Lightweight and portable equipment, suitable for transportation and rapid response.

4. Bid Evaluation The selected bidder is selected from the number of bidders who submitted satisfactory bids on the principle of giving preference to the bidder with the lowest price bid.

5. The tender is carried out in one stage, delivery according to the schedule agreed by the Parties and within the announced period - within 1 month. from the date of conclusion of the contract.

6. Before the provision of financial resources in the manner prescribed by this Law, a contract may be concluded with the condition that procurement within its framework can be made if the necessary financial resources are provided. A contract concluded in accordance with this part is terminated if financial resources for the implementation of the contract have not been provided within six months following the day of its conclusion. This part may apply if:

1) the customer cannot preliminarily predict (calculate) the amount of financial resources required for procurement;

2) the supply of goods, performance of work or provision of services, counting from the moment of provision of financial resources for this purchase, must begin within a period during which the use of any competitive form of procurement in terms of time is impossible.

7. The bid price presented in the application is indicated in the RA currency, written in numbers, letters, includes the calculation procedure.

8. The calculation of the bid price submitted in the application must include all the costs of the applicant, including transportation to the site of HrazDPP.

9. Applications will be opened in September 26 of 2024 at 11:00am.

10. In the process of this procurement, the evaluation commission is guided by the provisions of the Law of the Republic of Armenia "On Procurement" and is regulated by the procedures approved by these organizations for conducting procurements carried out by public organizations on the territory of the Republic of Armenia.
